# Administration of the Government of Alberta's Dental Assistance for Seniors Program (DASP) and Low Income Health Benefit (LIHB) program dental benefits: virtual information session link and frequently asked questions and answers

On June 3, 2024, the administration of the Dental Assistance for Seniors Program (DASP) and Low Income Health Benefit (LIHB) program dental benefits will transition from the Alberta Dental Services Corporation (ADSC) to Alberta Blue Cross°.

LIHB programs include individuals enrolled in Assured Income for the Severely Handicapped, Alberta Adult Health Benefit, Alberta Child Health Benefit, Income Supports, Children's Services, Child and Youth Support, Supports for Permanency and the Family Supports for Children with Disabilities program.

This change does not impact the eligibility of members, their ID number or the fee guides currently in place for the programs. This change is only about who will be administering the programs on behalf of the Government of Alberta.

What group numbers do I use to submit claims to Alberta Blue Cross for DASP and LIHB programs as of June 3, 2024?

#### Where do I send DASP and LIHB dental program claims?

Until June 2, 2024, continue to send your dental claims to ADSC. Beginning June 3, 3024, regardless of the service date, send your claims and predeterminations electronically through CDAnet or mail them to Alberta Blue Cross (see details in the guestions and answers document).

### Will unprocessed claims or predeterminations that are sent to ADSC before June 3, 2024, be forwarded to Alberta Blue Cross?

No; any outstanding submissions sent to ADSC before June 3, 3024 will need to be resubmitted to Alberta Blue Cross on or after June 3, 2024.

#### As of June 3, 2024, how can providers submit exceptions to Alberta Blue Cross?

Exceptions, vouchers and Family Supports for Children with Disabilities and Supports for Permanency orthodontic treatment plans must be submitted through the Alberta Blue Cross provider website. #### What changes have been made to DASP and LIHB coverage effective June 3, 2024?

DASP	As of June 3, 2024	
Scaling	Eight units of scaling in a rolling 12-month period. No exceptions allowed.	
General anesthesia	Twelve units of general anesthesia in a rolling 6-month period. No exceptions will be allowed.	

LIHB program	As of June 3, 2024	
Scaling	Eight units of scaling in a rolling 12-month period. No exceptions allowed.	
General anesthesia	Twelve units of general anesthesia in a rolling 6-month period. No exceptions will be allowed.	

These changes were developed in consultation with the Alberta Dental Association.
