

COVID-19 Rapid Antigen Test Kits Update

As previously communicated in [Alberta Blue Cross® benefact 1144](#), issued November 2023, all Albertans can get free COVID-19 rapid antigen testing kits for at-home use from participating pharmacies across the province. Pharmacies are encouraged to consider stocking these test kits to support patients and their families who are looking to test for COVID-19 infection.

Please see [Alberta Blue Cross benefact 1180](#), issued June 2024, for additional information regarding the use of rapid antigen testing kits to help patients and clinicians determine eligibility for Paxlovid under government-sponsored drug plans. Pharmacy teams should discuss how to best help patients access Paxlovid—it may be helpful to keep Paxlovid in stock to prevent delays and ensure patients have access to this medication in a timely manner.

COVID-19 rapid antigen test kits are available to order from pharmacy wholesale distributors. While federal supply remains available, we would like to remind pharmacies to check both their primary and secondary wholesalers when placing orders for the federal supply in the event your primary wholesaler does not have stock. **Note: costs associated with the distribution of COVID-19 rapid antigen test kits from wholesalers are reimbursed by Alberta Health.**

Alberta has secured additional federal supply of free COVID-19 rapid antigen tests; this supply consists of several different brands of tests. These brands are authorized by Health Canada. Incoming supply includes COVID-19 rapid antigen test kits manufactured by BTNX, Roche, Abbott Panbio and Artron. **Please note, each brand has a different expiry month (see the table below for more details).**

Similar to the COVID-19 rapid antigen tests manufactured by BTNX, please be advised that the Roche, Artron and Panbio COVID-19 rapid antigen tests also use lateral flow immunoassay technology to detect specific proteins associated with Severe Acute Respiratory Syndrome coronavirus 2 (SARS-CoV-2) using a nasal swab that can be self-administered.

Like BTNX, the above noted manufacturers' COVID-19 rapid antigen tests are designed for ease of use, often requiring minimal training for administration and interpretation of results. Additionally, these tests are suitable for self-use as well as for other point-of-care testing settings in the community. Pharmacists are encouraged to advise individuals to carefully follow the manufacturer instructions in conducting a rapid antigen test. An optimal specimen for performing a rapid antigen test involves using the included swab to rub the insides of the cheeks on both sides, the back of the throat on both sides (the tonsil area) and then both nostrils.

Please note, expired test kits should not be returned to the distributor or manufacturer.

Data elements for direct bill claiming

Pharmacy team members can submit a claim for \$60 per case to Alberta Blue Cross for each case of test kits they order and receive from their pharmacy wholesale distributor (McKesson, Imperial, Kohl & Frisch or Matrix SDM).
