## **Alberta Outreach Immunization Program updates**

The Alberta Outreach Immunization Program focuses on providing immunization services to those at highest risk of severe outcomes, hospitalization and death due to vaccine-preventable diseases, such as influenza, COVID-19 and invasive pneumococcal disease. Individuals living in senior congregate care settings are more likely to have underlying health conditions and face barriers to accessing immunization services in the community, which increases the risk of poor health outcomes. A comprehensive, coordinated approach to offering immunization services to those living in senior congregate care settings is necessary to reach the goals of the program.

## **Updates to Alberta Outreach Immunization Program vaccine fees**

Effective April 15, 2024, Alberta Health has applied a retroactive fee increase of \$4 per dose for all publicly funded vaccines administered for the Alberta Outreach Immunization Program (Outreach program), increasing the fee from \$13 to \$17 per dose. The \$4 increase will be applied only to pharmacies participating in the Alberta Outreach Immunization program to support the travel time and additional resources (such as personnel and equipment) required to provide Outreach vaccinations. Feedback was obtained from several groups, including counsel from the Alberta Pharmacists' Association (RxA).

Alberta Blue Cross® has completed a review of the Alberta Outreach Immunization Program claims that were administered to residents during the period of April 15 to June 30, 2024, and will be applying the fee increase adjustment. Pharmacies participating in the spring Outreach program should anticipate retroactive payment to appear on their August 29 payment.

Ongoing work between Alberta Health, RxA and Alberta Blue Cross will enable the incorporation of Outreach program vaccine fee increase into the claim system commencing fall 2024. Outreach program injections provided after June 30 and before the fall commencing date will be captured in the next retroactive reconciliation to ensure proper compensation for all Outreach services.



## **Retroactive claims adjustment for the Alberta Outreach Immunization Program**

The payment details of these adjustments for Outreach program claims will appear on the reconciliation report dated August 20, 2024, along with other APS claims within this pay period. An electronic funds transfer deposit will be made for payment for these adjustments on August 29, 2024. The drug quantity on the reconciliation report reflects the number of claims that the additional \$4 was applied to, and the drug cost reflects the total amount paid for these adjustments.
