IMPORTANT NOTICE FOR PHARMACY PROVIDERS

Alberta Blue Cross® administers benefits for the Government of the Northwest Territories (GNWT), including support for their Extended Health Benefits (EHB) for Seniors and Métis Health Benefits programs, as well as the Specified Disease Condition program. In September 2023, the GNWT announced a new EHB program to replace the Specified Disease Conditions program. The Specified Disease Conditions program will end on September 2, 2024. The new EHB program will become effective on September 3, 2024, and will follow an annual income assessment for benefit eligibility.

The replacement of the Specified Disease Conditions program with the new EHB program will have no impact on seniors aged 60 and older, as their current benefits remain unchanged. Similarly, there are no changes for residents who access the Métis Health Benefits.

Any GNWT plan member inquiries, including Specified Disease Conditions plan members, can be directed to the **GNWT website** for further information. The **GNWT website** hosts all the program details and additional information, including **how to apply** and the **frequently asked questions** document.

Residents enrolled in the new GNWT EHB program will receive new ID cards from Alberta Blue Cross. There cards will have new ID numbers, as well as the new group number 23724. Under the new EHB program, coverage for pharmacy and medical supply benefits will vary dependent upon income band. Pharmacy claims for eligible residents may be submitted electronically through the Alberta Blue Cross PrideRT system with the below information:

- · Group: 23724
- Carrier Code: 11
- ID number: enter as a 10-digit number (filled with leading zeros)

All pricing rules will remain the same. The GNWT EHB program is payer of last resort for coordination of benefits. For additional information on all GNWT sponsored benefits plans, please see the **GNWT pharmacy reference guide for prescription drugs**.
